NOTIFICATIONS

No.D.26014/1/94-TRP, the 18th February, 2000. In partial modification of this Deptt's Notifications of even no dated 25.9.96 and 1.10.99 regarding free travel concession in MST Buses to the Bonafide Cancer patients, blind persons (both eyes), physically disabled persons, mentally retarded persons and 50% travel concession to the old aged persons beyond 65 years of age respectively, the Governor of Mizoram is pleased to authorise D.C. Lunglei, Saiha, Lawngtlai, Champhai, Mamit, Kolasib and Serchhip to issue concession Cards/Certificates in coordination with Director of Transport and in accordance with the procedure laid down in the Guidelines issued through the above Notification. A copy of the Guidelines is annexed for ready reference.

GUIDELINES FOR GRANT OF FREE TRAVEL CONCESSION TO BONA-FIDE CANCER PATIENTS, BLIND PERSONS (BOTH EYES) PHYSICALLY DISABLED PERSONS AND MENTALLY RETARDED PERSONS IN THE MIZORAM STATE TRANSPORT BUSES,

1. Cancer patients & mentally retarded persons with one accompanying attendant permanently residing in Mizoram will be allowed free travel concession in the Mizoram State Transport Buses for the purpose of Medical treatment/check up to and fro from the nearest MST Bus Station where they permanently reside, subject to the following conditions.

Cancer patients and mentally retarded persons shall be allowed free travel concession in the MST Buses while proceedings for medical treatment/check up and returning thereafter subject to the issue of valid tickets on production of concession card issued by the Director of Transport or by D.C.Lunglei/Saiha/Lawngtlai/Champhai/Serchhip/Mamit/Kolasib in prescribed form at Appendix-I.

- 2. Similar concession is also allowed in the MST Buses to blind persons (blind in both eyes) and orthopaedically disabled persons due to loss of limbs i.e. either both hands or both legs, permanently residing in Mizoram in town & all rural ordinary services on production of concession Card issued by the Director, Transport or D.C.Lunglei/Saiha/Lawngtlai/Champhai/Serchhip/Mamit/Kolasib in the prescribed form at Appendix-I(A).
- 3. The concession card shall be issued by the Director of Transport or by any Officer authorised by him on his behalf after careful consideration and on receipt of application in the prescribed form in Appendix-II from the bonafide cancer patients blind persons (both eyes)/ physically disabled persons/mentally retarded persons duly supported by Medical Certificate.
- 4. Application form free of cost shall be available in the office of the Director of Transport or any nearest office of Station Supdi/Asst. Station Supdi. on formal request.
- 5. The applicant should have a certificate to show that he is a cancer patient/blind persons (both eyes)/physically disabled person/mentally retarded person duly certified by the Authorised Medical Officer not below the rank of District Chief Medical Officer under his hand and seal.

GUIDELINES FOR GRANT OF FIFTY PER CENT CONCESSION IN MST BUS FARES TO THE AGED PERSONS OF MIZORAM BEYOND 65 Yrs. OF AGE

Eligibility Conditions:

- 1. The aged person should be a domicile of Mizoram to be supported with certificate from D.C. concerned.
- 2. He/She must attain the age of 65 years or more.
- 3. Application in Prescribed Form for Grant of 50% concession of MST Bus Fare should be submitted to Director of Transport alongwith Age Certificate from Registrar of Birth & Death and 2(two) copies of Passport size photographs.
- 4. 50 P.C Concession will be allowed on production of Concession certificate from Director of Transport, or from D.C. Lunglei/Saiha/Lawngtlai/Champhai/Mamit/Kolasib/Serchhip at the Bus Ticket Booking Counter.
- 5. No person other than the Granttee shall be allowed in the seat alloted.
- 6. The Concession may be used for travel within and outside Mizoram where MST Bus is in operation.
- 7. The Validity of the Concession will be for one year which will be renewable on expiry of the permit on production of live certificate or appearance by the Granttee himself.
