SCHEDULE-II

DESCRIPTION & MAP OF RUNNING BOUNDARY OF PLANNING AREA/ BOUNDARY :

The Planning area for Thenzawl consist the area within the following limit.

STARTING POINT :

Pillar No. 1. To the north west corner of Thenzawl at the confluence of R. Vanva with the stream which comes from IB (PWD) and at the point of 92°45'16" Lat. and 23°18'21" Long. Pillar No. 1. is fixed.

NORTH

Pillar No. 2: From the starting point, the boundary follows R. Vanva to north-eastwards and meets the hill top of Saihum tiang at the point of 92°46'26" Long. and 23°19'7" Lat. Pillar No. 2 is fixed at this point.

Pillar No. 3: From Pillar No. 2, the boundary goes eastwards and meets Lau lui kham (cliff) at the point of 92°46'53" Long. and 23°18'53" Lat. and Pillar No. 3 is fixed here.

Pillar No. 4: From Pillar No. 3, the boundary follows the said cliff southwards and meets Vawmdelh lui at the point of 92°46'56" Long. and 23°10'28" and Pillar No. 4 is fixed here.

Pillar No. 5: From Pillar No. 4, the boundary follows Vawmdelh lui eastwards upto the confluence with F. Lau and Pillar No. 5. is fixed at this point.

Pillar No. 6: From Pillar No. 5, the boundary follows Mualiet lui to eastwards and meets Sakhik tiang, most portion at the point of 92°47'42" Long. and 23°19'29" Lat and Pillar No. 6 is fixed at this point.

EAST

Pillar No. 7: From Pillar No. 6, the boundary meets Bakpuk lui hnar kawn at the point is 92°48'9" Long. and 23°18'5" Lat. and Pillar No. 7 is fixed here.

Pillar No. 8: From Pillar No. 7, the boundary goes southwards and meets Se-kaih kawn and from this it follows the ridge line southwards and meets the Lungrang Village at the point of 23°16'52" Lat. and 92°48'14" Long. and Pillar No. 8 is fixed here.

Pillar No. 9: From Pillar No. 8, the boundary meets Lendur lui hnar and follows the same stream to south western direction and Pillar No. 9 is fixed at the confluence with Kawnpui lui.

SOUTH

Pillar No. 10: From Pillar No. 9, the boundary follows Khangte lui to south west upto the confluence with Saphak lui and Pillar No. 10 is fixed at this point.

Pillar No. 11: From Pillar No. 10, the boundary again follows Saphak lui south western wards upto the confluence with R. Vanva lui and Pillar No. 11 is fixed at the ending point of 92°14'42" Long. and 23°14'34" Lat.

Pillar No. 12: From Pillar No. 11, the boundary again follows R. Vanva lui northwards upto the starting point where Pillar No. 1 is fixed at already mentioned in the first paragraph.
