NOTIFICATION

No. D-1103I/7/99-LAD/13, the 2nd March, 2000. In exercise of the power conferred by section 4 of the Mizoram Urban and Regional Development Act, 1990 as amended in 1996 (Mizoram Act. No. 12 of 1990) and in consultation with Bilkhawthlir Town Planning & Development Committee and the Mizoram Urban Planning Development Board, the Governor of Mizoram is pleased to notify with immediate effect that the area comprising the Bilkhawthlir and other areas indicated in Schedule-I appended to this Notification to be Bilkhawthlir Planning Area for the purposes of the said Act, which shall be called by the name of the 'BILKHAWTHLIR PLANNING AREA' and the boundary of the said Planning Area shall be as indicated in Schedule-II enclosed.

SCHEDULE — II

DESCRIPTION OF RUNNING BOUNDARY OF BILKHAWTHLIR PLANNING AREA WITH MAP :

Starting Point :

The first Boundary Pillar is fixed at the coordinate of 92 deg-42'-26" longitude, 24 deg-18'-55" Latitude in the western edge of the road leading to Aizawl, the place is locally known as 'Quarry Peng'

- South :** From Boundary Pillar No. 1 the boundary line follows Hmar Luanglui, Boundary Pillar No. 2 is fixed at the coordinate of 92 deg-42'-00" longitude, 24 deg-19'-15" latitude.
- West :** From Boundary Pillar No. 1 the boundary line follows small stream, directed Laringa's farm kawn. (saddle) and follows small stream. The stream meets Chhimluang river. The boundary line follows Chhimluang lui upto Khankawn, and then runs along small stream upto the tri-junction is treated as Pillar No. 3 and the coordinate is 92 deg-42'-54" longitude and 24 deg-21'-14" latitude.
- North :** From Boundary Pillar No. 3 the boundary line runs along Daplei lui upto KM Stone No. 4 which is in the eastern edge of NH-54. From KM Stone No. 4. the boundary line follows Thingdelhlui upto the co-ordinate of 92 deg-44'-25" latitude at this point Boundary Pillar No. 4 is fixed.
- East :** From Boundary Pillar No. 4 the boundary line runs to the following points, Lalzui Huan mawng Kawn, Thakhuma chul kawn, Pu Khianga kuhva huan bul Kawn (this point is just adjacent to footpath leading to Champhai). Then it follows small stream upto the tri-junction of Lungzawn lui. From this point the boundary line passes through the following points, Camp Mualmawng Kawn, Laloeiseia huan kawn and tri-junction of stream where Boundary Pillar No. 5 is fixed at the co-ordinate of 92 deg-43' 11" longitude, 24 deg-18'43" latitude.
- South :** From Boundary Pillar No 5 the boundary line enjoins Boundary Pillar No. 1 which is fixed at 'Quarry Peng'.
