No. A. 12018/1/95 DP&AR(CSW), the 15th March, 2000. In exercise of the powers conferred by the proviso to Article 309 read with Article 234, of the Constitution of India, the Governor of Mizoram is pleased to amend, the Mizoram Judicial Service Rules, 1989 namely:—

- 1. Short tittle: (i) These Rules may be called the Mizoram Judicial Service (Second Amendment) Rules, 2000. and commencement:-
  - (ii) They shall be deemed to have come into force with effect from 17th Nov. 1986 on which the Mizoram Judicial Service Rules 1986 was notified in the Mizoram Gazette.
- The words "non-functional" against Grade I Senior, Grade I Junior, Grade II and Grade III shall stand deleted. 2. Amendm-: (i) ent of subrule (1) of Rule 23:-
- 3. Amendment The Provision in sub-rule (2) of Rule 23 may be substituted of subas below :-
- rule (2)(a) (a) A member of the Service in Grade IV shall be eligible for (b) (c) (d) consideration for promotion to Grade III after completion of and 5(five) years of regular service in Grade IV or in any equivalent proviso of duty posts in the Schedule-A calculated from the year of entry in . Rule 23 - such post and subject to availability of vacancy.

- (b) A member of the service in Grade III shall be eligible for consideration for promotion to Grade II after completion of 5 (five) years of regular service in Grade III and/or in any equivalent duty post in the Schedule-A calculated from the year of entry in such post and subject to availability of vacancy.
- (c) A member of the service in Grade II shall be eligible for consideration for promotion to Grade I (Junior) after completion of 5(five) years of regular service in Grade II or in any equivalent duty post in the Schedule-A calculated from the year of entry in such post and subject to availability of vacancy.
- (d) A member of the service in Grade I (Junior) shall be eligible for consideration for promotion to Grade I (Senior) after completion of 2 (two) years of regular service in Grade I (Junior) or in the equivalent duty post in the Schedule-A calculated from the year of entry in such post and subject to availability of vacancy.
- 4. Amendment of Sub-rule 3&4 of Rule 23 :-

Sub-rule 3 and 4 of the MJS Rules, 1989 shall stand deleted.
