SCHEDULE-II

BOUNDARY DESCRIPTION OF MELBUK (KHAWNUAM)

STARTING: The boundary line starts at the point where Theitat Kawr (stream) POINT crosses the Melbuk-Champhai Road where Pillar No. 1 is erected.

- NORTH: From B. P. No. 1, it follows the Theitat Kewr downstream upto a point where it is joint by Vengchiak Turkhur lui (stream) where B.P. No. 2 is erected, and runs downstream upto its confluence with another stream where B.P. No. 3 is erected. From B.P. No. 3, it follows the stream upwards until it reach the top of Hualsela Tlang where B.P. No. 4 is erected. From B.P. No. 4, it runs eastward at the side of the Hualsela Tlang (ridge) above the cliff until it meets a cliff in the eastern side at B.P. No. 5.
- EAST: From B.P. No. 5, it runs down the ridge until it reach Tuikhur Lui (stream) at B.P. No. 6, From B.P. some extent where B.P. No. 7 is erected. From B.P. No. 7, it runs upwards and cut a saddle near Authangkhawk Tlang (Hillock) and reach Dillui (stream) at B.P. No. 8.
- SOUTH: From B.P. No. 8, it follows Dillui upstream upto a point where it is crossed by an old abandoned road to Zoknawthar where B.P. No. 9 is erected. From B.P. No. 9, it follows the old abandoned road until it is cut by Tukhurlui (stream) at B.P. No. 10.
- WEST: From B.P. No. 10, it follows the stream upward upto B.P. No. 11. From B.P. No. 11, it runs to the North crossing a saddle below the Tuichhintlang (Hill) upto Theitat Kawr where B.P. No. 12 is erected. It then follows Theitat Kawr downstream and meet Melbuk-Champhai Road at B.P. No. 1
