NOTIFICATION

No.A.12018/1/90-PAR (GSW), the 24th March, 2000. In exercise of the powers conferred by the proviso to Article 318 of the Constitution of India, the Governor of Mizoram is pleased to make the following regulations regarding to the recruitment to the posts indicated in the Annexure - I.

1. Short title and commencement (i) These Regulations may be called the Mizoram Public Service Commission (Group 'B' Post) Recruitment Regulations, 2000.
(ii) They shall come into force on the date of their publication in the Official Gazette.
2. Application The Regulations shall apply to the post specified in column 1 of the Annexure - I hereto annexed.
3. Number of posts, classification and scale of pay, method of recruitment, age limit and other qualification. The number of the said post (s), their classification and the scale of pay attached thereto shall be as specified in the Annexure - I :
Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/or Scheduled Tribes by five years or in accordance with the orders issued by the Government of Mizoram from time to time.
4. Disqualification No person—
 - a) who has entered or contracted a marriage with a person having a spouse living, or

b) Who, having a spouse living, has entered into or contracted a marriage with any other persons, shall be eligible for appointment to the said post.

Provided that the Commission may, if satisfied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of these Regulations.

5. Training and Departmental Examination.

The person recruited under these Regulations shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

6. Transfer and posting

Notwithstanding anything contained in these Regulations, the Commission, in public interest may transfer any Officer or Official recruited in accordance with these Regulations to the post/posts/service specified in the Annexure to these rules to any other post or position which is equivalent in rank or grade within the Commissions establishment

7. Power to relax.

Where the Commission is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons, to be recorded in writing, relax any of the provision to these Regulations with respect to any class or category of persons.

8. Reservations, other concessions.

Nothing in these regulations shall effect reservation and other concession required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the State Government from time to time in this regard.

9. Repeal and Savings.

All the Regulations pertaining to the recruitment to these posts preceding to these rules are hereby repealed.

Provided that any order made or anything done or any action taken under the Regulationss so repealed shall be deemed to have been done or taken under the corresponding provisions of these rules.
