NOTIFICATION

No. A. 12018/10/82 -APT(B), the 5th May, 2000. In exercise of the powers conferred by the Proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of Hindi Teacher Middle School under the Department of Education and Human Resources Development namely:—

- 1. Short title (i) These Rules may be called the Mizoram Education and an i commencement. Human Resources Development, (Group 'C' posts) Recruitment Rules, 2000.
 - (ii) They shall come into force on the date of their publication in the Official Gazette.
- 2. Application. These Rules shall apply to the post (s) specified in column 1 of the Annexure hereto annexed.
- 3. Number of The number of the said post(s), their classification and the post, classification and the scale of pay attached thereto shall be as specified in Columns tion & Scale 2 to 4 of the Annexure aforesaid.
- 4. Method of The age limit, qualification and other matters relating to Rectt., age limit the said post shall be as specified in columns 5 to 14 of and other the Annexure aforesaid. qualification.
- 5. Disquali- No person—fication.
 - (a) Who has entered into or contracted a marriage with a person having a spouse living, or
 - b) who, having a spouse living, has entered into or contracted a marriage with any other person, shall be eligible for appointment to the said posts.

Provided that the Government of Mizoram may, if satisfied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of these rules.

6. Training and Departmental Examination.

... J. 3. .

- Every Government servent secruited under these Rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.
- 7. Power to transfer.

Notwithstanding anything contained in these Rules, the Governor of Mizonem in public interest, shall have the right and power to transfer any Officer so recruited under these Rules to any other post or position which is equivalent in rank or grade.

8. Power to relax.

Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing, in consultation with the Departmental Promotion Committee/M.P.S.C, as the case may be, through the Department of Personnel & Admn. Reforms, relax any of the provisions to these Rules with respect to any class or category of persons.

9. Reservation and other concessions.

Nothing in these Rules shall affect reservation or other concessions required to be provided for the Scheduled Castes/ the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Government of Mizoram from time to time in this regard.

10. Repeal and Savings.

All Rules pertaining to the recruitment to these post(s) framed by the Governor of Assam or by Government of Assam and were in force in the erstwhile Mizo District and continued to be in force in pursuance of Govt. of India, Ministry of Home Affairs Notification No. 14/21-HMP (ii) dated 21.1.72 and framed by the Government of Mizoram under Notification No. A. 12018/59/80-APF(B) dt. 16.1.1989 and published in the Mizoram Gazette Issue No. 3 (A) dt. 16.1.1989 and Notification No. A. 12018/10/82-APT (B) dt. 16.7.1996 and published in the Mizoram Gazette Issue No. 314 dt. 23.7.1996 are hereby repealed.

Provided that any order made or anything done or any action taken under the Rules so repealed or under any general orders ancillary thereto, shall be deemed to have been done or taken under the corresponding provisions of these Rules.
