| Method of Recrt., age limit and other qualifications. | 4. The age limit, qualifications and other matters relating to the said post shall be as specified in Columns 5 to 14 of the Annexure aforesaid. |
| Disqualification.                                     | 5. No person —                                                                                                                                   |

(a) Who has entered into or contracted a marriage with a person having a spouse living; or

- (b) Who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post(s).

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt any such person from the operation of these Rules.

Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing in consultation with the Departmental Promotion Committee through the Department of Personnel & Admn. | Reservation and other concessions.     | 9. | Repeal and Savings.                    | 10. All Rules pertaining to these posts framed by the Govt. of Assam or Governor of Assam and continued to be in existence in pursuance of Govt. of India, Ministry of Home Affairs' Notification No.14/21/71-HMP dated 21.1.1972 and framed by the Govt. of Mizoram vide Notification No. A. 12018/21/80-APT(B) dated 11.3.1988 and published in the Mizoram Gazette Issue No. 35, dated 11.3.1988 in respect of Superintending Pharmacist and Notification No.MFP.174/73-75/21, dt. 3.4.75 and published in the Mizoram Gazette Issue No. 12 dt. 24.4.75 in respect of Head Pharmacist are hereby repealed. |

Provided that any order made or anything done or any action taken under the Rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these Rules.
