## NOTIFICATION

No.K.15011/82/99-REV, the 24th May, 2000. Whereas it appears to the Appropriate Government (hereinafter referred to as the Government of Mizoram) that the land specified in the scheduled thereto. (hereinafter referred to as the "said "land") is likely to be needed for public purpose viz. Acquisition of additional land at Falkawn for Establishment of a State Referal Hospital.

Now, therefore, the Government hereby notifies, under sub-section (i) of section 4 of the Land Acquisition Act, 1894 (Central Act 1 of 1894) hereinafter referred to as the said Act) that the said land is likely to be needed for the purpose specified above.

2. Any person interested in any land being notified may submit their objection to the acquisition in writing to the A.S.O.-I, Aizawl District/Collector. Aizawl within a period of 30 days from the date of publication of this Notification in the Mizoram Gazette, who will dispose of the objections and claims as per provision of Section 5-A of the Land Acquisition Act-1894.

3. All persons interested in the said land are hereby warned not to obstruct or interfere with any surveyor or other persons employed upon the said land for the purpose of the said acquisition. Any contract for the disposal of the said land by sale, lease, mortgage, assignment, exchange of the status of Pass or otherwise or any outlay commenced or improvements made therein without the sanction of the A.S.O.-I Azl. Dist./Collector will, under clause (Seventh) of Section 24 of the said Act, be disregarded while assessing compensation for such parts of the said land as may be finally acquired.

4. All persons/landowners who had preferred their claims pursuant to Notice under section 9(i) of Land Acquisition Act, 1894 issued by the Land Acquisition Collector vide his letter under Memo No.K.15011/1/98-DC (REV) dt.7.5.99 need " not re-submit their claims and no claims should be entertained within the earlier notified area.
