#### **NOTIFICATION**

No. 56./2000(3)/JUD.III- In pursuance of sub-paragraph (2) of paragraph 17 of the Election Symbols (Reservation and Allotment) Order, 1968, the Election Commission of India hereby makes the following further amendments to its Notification No. 56/2000/JUD.III, dated 30th July, 1999, as amended from time to time, namely :-

**1. In Table II(State parties), appended to the said Notification**

- (i) against the entry "Andra Pradesh" under column 2, the entries relating to "1. NTR Telugu Desam Party (Lakshmi Parvathi)", under columns 3, 4 and 5 shall be deleted, and the entry "2. Telugu Desam" under column 3, shall be substituted by the entry "Telugu Desam",
- (ii) against the entry "Assam" under column 2, the entries relating to "3. United Minorities Front, Assam", under columns 3, 4 and 5 shall be deleted, and the entry "4. Communist Party of India (Marxist-Leninist) (Liberation)" under column 3, shall be substituted by the entry "3. Communist Party of India (Marxist- Leninist) (Liberation)";

- (iii) all the entries under columns 1 to 5, relating to Chandigarh and Dadra & Nagar Haveli, shall be deleted;
- (iv) against the entry "Haryana" under column 2, the entries relating to "1. Haryana Vikas Party" and "3. Samata party", under columns 3, 4 and 5 shall be deleted, and the entry "2. Indian National Lok Dal" under column 3, shall be substituted by the entry "Indian National Lok Dal";
- (v) against the entry "Maharashtra" under column 2, the entries relating to "1. Republican Party of India", under columns 3, 4 and 5 shall be deleted, and the entry "2. Shivsena" under column 3, shall be substituted by the entry "Shivsena";
- (vi) against the entry "Manipur" under column 2, the entries relating to "4. Rastriya Janata Dal", under columns 3, 4 and 5 shall be deleted, and the entry "5. Samata Party" under column 3, shall be substituted by the entry "4. Samata Party";
- (vii) against the entry "Meghalaya" under column 2, the existing entries under column 5 relating to "3. United Democratic Party", shall be substituted by the entries "Mawlai Nonglum, Shilong-793008, (Meghalaya)";
