NOTIFICATION

No. C. 31016/5/97-EXC, the 18th August, 2000. On the expiry of the existing term of the District Prohibition Committees and in exercise of the powers conferred by the provisions to section 59 of the Mizoram Liquor Total Prohibition Act, 1995, also read with sub rules (1), (3) and (4) of the Mizoram Liquor Total Prohibition Rules 1996 and sub-rule (2) of Rule 16 of the Mizoram Liquor Total Prohibition (Amendment) Rules, 1997, the Governor of Mizoram is pleased to re-constitute District Prohibition Committees at the District level for Aizawl District, Lunglei District, Champhai District, Serchhip District, and Kolasib Districts respectively consisting of the following officials and non-officials resident of the District concerned with immediate effect and for a term of 2 (two) years which may be extended for any longer period as deemed necessary by the Government.
