NOTIFICATION

No. G. 17012/5/93-F. Est, the 11th August 2000. Consequent upon the bifurcation of the erstwhile Directorate of Health Services into two Directorates, the Governor of Mizoram is pleased to demarcate and specify the powers, functions and responsibilities of the Director of Health Services and the Director of Hospitals and Medical Education as follows :-

- PLANNING & BUDGETING, APPROPRIATION AND RE-APPOPRIATION :
 The power of Planning, Budgeting, Appropriation and re-appropriation, and the budgetary control, including Administration of loans and advances and issue of LOC will be vested in the Administrative Departments
 - 2. TECHNICAL POWERS : Without prejudice to the Rules and notilications issued in this regard by the Government of Mizorani from time to time, the technical powers of the two Directors shall be as provisions of the relevant codes/manuals. Technical powers shall, however, not be construed as financial powers.
 - 3. APPOINTMENT AND Both the Director of Health Services and DISCIPLINARY AUTHORITY: Both the Director of Hospitals and intedical Education shall be appointing authority including promotion in their respective Departments/Directorates in respect of non-gazetted officers, including group 'C', and they shall exercise the powers of disciplinary authority under CCS (CCA) Rules, 1965. Common seniority

shall be maintained for all the regular staff of the Department by Admininistrative Department. Appointments/Promotions shall be made by concerned Director on the recommendation of a DPC chaired by the Secretary or concerned Director, as the case may be

POSTING — Initial inter-transfer of staff shall be done by Administrative Departments. Thereafter, both the Director of Health Services and Director of Hospitals and Medical Education shall exercise the power of transfer and posting of all non-gazetted staff under their respective controls.

> - Both the Director of Health Services and the Director of Hospitals and Medical Education shall release and control the budget allocation to their -respective subordinate offices.

- The two Directors shall have separate DDO, Accountant and Cashier and maintain separate accounts. The two Directors shall jointly utilise the services of joint Director (Malaria), Deputy Director (Nursing), Deputy Director (Admn) FAO, Assistant Director (Drug Control).

The two Directors shall deal with separate Treasuries of Aizawl.

The Government of Mizoram reserves the powers of review and revision of the provisions contained in this notification from time to time.
