## NOTIFICATION

No.A.12018/1/93-P&AR(GSW), the 19th September, 2003. In exercise of the powers conferred by the Proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following Rules relating to the recruitment to the Post of Instructor, Engineering Drawing, Industrial Training Institute under Labour and Employment Department, Government of Mizoram, namely :-

- 1. Short title aud commancamant, (1) These Rules may be called the Mizoram Lobour and Employment Department (Group 'C' post) Recruitment Rules, 2011.
  - (2) They shall come into force on the date of their publication in the Oricial Gazette.
- 2. Application. The Rules shall apply to the post specified in column 1 of the Annexure-1 nereto annexed.
- 3. Number of Posts, The number of the said post (s), their classification and the classification & scale of pay attached thereto shall be as specified in Co-Scale of pay. lumns 2 to 4 of the Annexure-1 aforesaid.
- 4. Method of The age limit, qualifications and other matters relating to Rectt., age limit the said post shall be as specified in Columns 5 to 14 of and other quali- the Amexure-1 aloresaid. fication.

Provided that the age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Seneduled Castes, Scheduled Trabes and other special categories of persons in accordance with the orders issued by the Central Gove, or Gove, of Mizoran from time to time.

5. Disqualification.

## No person-

a) Who has entered into or contracted a marriage with a person having a spouse living, or

ł

b) who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment • to the said post (s).

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt any such person from the operation of these rules.

- 6. Training and Departmental Examination. Every Government servant recruited under these Rules shall undergo such training or pass such Departmental Examinations as may be prescribed from time to time.
- 7. Power to transfer. Notwithstanding anything contained in these rules, the Governor of Mizoram in public interest, shall have the right and power to transfer any officer so recruited under these rules to any other post or position which is equivalent in rank or grade.
- 8. Power to relax. Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing in consultation with the Department of Personnel and Administrative Reforms, relax any of the provisions of these rules with respect to any class or cateorgory of persons.
- 9. Reservation and other concessions. Nothing in these Rules shall affect any reservations or other concessions required to be provided for the Scheduled Tribes, Scheduled Castes and other categories o. persons in accordance with the order issued by the Central Government or Government of Mizoram from time to time in this regards.

On and from the commencement of these Rules the Mizoram Labour and Employment Department (Group 'C' posts) Recruitment Rules, 1987 notified under the Government of Mizoram Notification No.A.12018/4 (n)/85-P&AR 'C' dt.25.8. 87 and published in the Mizoram Gazette issue No.90(A) dt.25.8.87 shall stand repealed, to and extend as the same relates to the post of Instructor, Engineering Drawing, Industrial Traning Institute only.

Provided that any order made or anything done or any action taken under the Rules so repealed or under any general orders ancillary thereto, shall be dee ned to have been made, done or taken under the corresponding provisions of these Rules.
