### **'NOTIFICATION**

No. K. 15011/82/99-REV, the 15th September, 2000. Whereas by Government Notification K. 15011/82/99-REV, dt. 24. 5. 2000 published in the Official Gazette and two daily newspapers, it was notified under section 4 of the Land Acquisition Act, 1894 (Central Act 1 of 1894) (hereinafter referred to as the "said Act" that the land specified in the schedule appended to the said 'Notification was likely to be needed for the purpose namely, Acquisition of land at Falkawn for Establishment of State Referral Hospital.

And whereas the appropriate Government (herainafter referred to as the "Government of Mizoram") after considering the report made under sub-section (2) of the section 5 (A) of the said Act needed for the purpose specified above.

Now, therefore, the Government declares under section 6 of the said Act that the said land is required for the public purpose specified above.

The Government also appoints, under clause (C) of section 8 of the said Act that Asstr. Settlement Officer-I, Aizawl to perform the functions of a Collector for all proceedings hereinafter to be taken in respect of the said land and directs him under section 7 of the said Act to take order for the acquisition of the said land.

The Collector shall there upon cause the land to be measured and make a plan of the same under section 8 of the said Act if not already done as per section 4 of the said Act, and dispose of all objections and claims after causing a public notice of not less than 15 days to the persons interested at convenient places on or near the land to be taken, stating the Government intention of taking over the pessession of the said land as per section 9 of the said Act, Then, the Collector shall submit a Draft Award to the Govt. of Mizoram after fulfilling the provisions under section 11 of the said Act.

A plan of the said can be inspected at the Office of the ASO-I. Aizawl till the final award is made under section 11 of the said Act.
