## **NOTIFICATION**

No. K. 15011/92/2000-REV, the the appropriate Government (hereinatter referred to as "The Government") that the land specified in the scheduled hereto/hereinafter referred to as the "said land" is likely to be needed for public purpose viz Land Acquisition for improvement and upgradation of Aizawi-Thenzawi-Buaugpui via Hmui ang section of Aizawi-Thenzawi-Buaugpui via Hmui ang section of Aizawi-Thenzawi-Lunglei road from 10 K. A to 100 K.M and Acquisition of Private Land at Zawngekkham Stone Quarry within islaubuang Village Council Jurisdiction.

Now, therefore, the Govt. hereby notifies under sub-section (1) of section 4 of Land Acquisition Act, 1824 (Central Act 1 of 1824) (hereinafter referred to as the "said Act") that the said land is likely to be needed for the purpose specified above.

All persons interested in the said land are hereby warned not to obstruct or interfere with any surveyor or other persons employed upon the said land for the purpose of the said acquisition. Any contract for the disposal of the said land by saie, lease, mortgage assignment, exchange or otherwise or any outlay commenced or improvements made thereon without the sanction of the Govt. after the date of application of this notification, with under clause (seventh) of section 24 of the said. Act, be disregarded white assessing compensation for such parts or the said land as may be finally acquired.

If the Govt. is satisfied that the said land is needed for the aforesaid purpose, a declaration to that effect under clause 6 of the said Act will be published in the official Gazette and in 2(two) Daily Newspaper and Public Motice thereof shall be given in due course. If the Acquisition is abandoned wholly or in part, the fact will also be notined in the same manner.

The Govt. further appoints under clause (C) of section 3 of the said Act, Pu V. Sapcanunga M.C.S. Special Land Acquisition officer, PWD to perform the function of a collector under the said Act in respect of the said Land.

A rough plan of the said land is available for inspection in the office of the Special Land Acquisition officer Engineer-in-Chief office PWD Azawl for a period of 30 days from the date of publication of this Notification in the Official Gazette.
