NOTIFICATION

No. B. 14015/1/97-TC/Pt, the 28th November, 2000. Whereas the State Government invited objections and suggestions in regard to the declarations of market areas within Aizawl town as per the provision of sub-section (1) of the Mizoram State Agricultural Produce Marketing (Regulation) Act, 1996 vide Mizoram Gazette issue No. 119 of 17.6.1998.

And whereas no objection and suggestion to that effect has been received by the Government even after 45 days from the date of issue of the notification as per sub-section (2) of section 3 of the said Act.

Now, therefore, in exercise of the power conferred by section 4 of the said Act, the Governor of Mizoram is pleased to declare Aizawl New Market as Market area with the following boundary descriptions for the purpose of the said Act, and also for the purpose of the Mizoram State Agricultural Produce Marketing Regulation (General) Rules, 1996.

BOUNDARY DESCRIPTION OF MARKET AREA OF AIZAWL NEW MARKET.

North : Starting from the point where the step from Zarkawt intersects the main road at Electric Veng, the boundary shall cross the main road reach the frontage of Pu Pu F. Neihkima's building and then run southwards, crossing the road leading to Electric Department office and then run along the compound of Electric Department and cross the southern gate of Electric Department office and run upto Pi Biaksangi's house. From here, the boundary shall run towards the east along Sakawrpului, bordering Electric Department's land, further it shall run between Electric Veng YMA Hall and Pu Hausiama's building to reach Electric Veng road. Then it shall run towards the coast along Electric Veng road upto Pi Thansiami's (w/o Khisbor Kumar) house.

- East :** The boundary shall further follow the main road i.e. Bungkawn-Ramthar road in southward direction from Pi Thansiami's house upto the step coming from Zion Street adjacent to Pu Thangruma's house.
- South :** From the step which joins Bungkawn-Ramthar Road, the boundary run shall upward along the step upto the frontage of Pu Thangruma's building at Zion Street and then cross the Street.
- West :** Straight from the point of intersections of Zion Street and the step, the boundary shall run towards the north along Zion Street excluding Dawrpui Middle School to ultimately join the starting point, i.e. the point of intersection between the step from Zarkawt and Electric Veng road opposite Pu F. Neihkima's building.

This supersedes the earlier notification issued even number dt. 16.10.2000.
