#### NOTIFICATION

No. B. 1401/97-TC/Pt, the 28th November, 2000. Whereas the State Government invited objections and suggestions in regard to the declaration of market areas within Aizawl town as per the provision of sub-section (1) of the Mizoram State Agricultural Produce Marketing (Regulation) Act, 1996 vide Mizoram Gazette issue No. 119 of 17. 6. 1998.

And whereas no objection and suggestion to that effect has been received by the Government even after 45 days from the date of issue of the notification as per sub-section (2) of section 3 of the said Act.

Now, therefore, in exercise of the powers conferred by section 4 of the said Act, the Governor of Mizoram is pleased to declare Aizawl Bawngkawn Market as market area with the following boundary descriptions for the purpose of the said Act and also for the purpose of the Mizoram State Agricultural Produce Marketing Regulation (General) Rules, 1996.

#### BOUNDARY DESCRIPTION OF MARKET AREA OF AIZAWL BAWNGKAWN MARKET :—

**NORTH :** The boundary shall run from Sairang road between Primary School II and YMA Hall. It shall run along Pi Dailovi's house then cross Bazarlui, and then along Pu Lalthanmawia's Bez lel workshop. The boundary thereafter shall run around the backyard of Pu K. Kawia's house and then towards the east along the step near Pu Remthanga's house intersecting the step approaching the market from here, the boundary shall run to the eastern boundary of Baptist Church and then run up hill along Aizawl—Lunglei road northwards upto the approach road of Pu K.L. Berema, S.E. PWD (Retd) residence.

- EAST :** The boundary line shall then cross the main road from the approach road of Pu K.L. Berema's residence towards Pi Sangliankhumi's courtyard from here it shall run towards the south along Aizawl—Lunglei main road upto ITI/College Veng Link road.
- SOUTH :** From ITI/College Veng link road the boundary shall turn towards Sairang road upto the frontage of Pu H. Thanga's building and then run along Sairang road, then along the step near Pu Thangluaia's house upto Bazar luikawr.
- WEST :** From Bazar luikawr the boundary shall further run along the backyard of Pu Bawlchhuaka, E.E., PWD building and then run along the step towards Sairang road including Primary School II and then join the Northern boundary.
