I. HRUAIKAWN V/C BOUNDARY :

Bulbekzawl nen ramri Sihmit Lui chu starting point a hmangin, Pu Sangkima Leilet tulak kawr khawchhak lam ta ziwth chhovin kawn thlen hnaah hmarchnak lam hawin tlangdungar chhovin Bulbekzawl Lawidai koah kal zelin Hruaikawn Meidet tlang chhipao kal liamin Faikham a fin ang.

Faikham chu chhimchhak zawnga zawk zelin, Tuidir kawr hnai a fin ang. Tuidir kawr chu khawchhak zawnga zawk thlai Tiau lui a fin ang. Tiau lui chu hmar zawnga zawk chhovin Thilipui kawr atangin hmarlam kawte a su a. Chu kawte chu khawthlang lam hawia zawk chhovin Hruaikawn dilab'a bang liamin khawthlang zawngin Hruaikawn kawr a zawk thla a. Kurung lui a fin a, Kurunglui chu chhimchhak hawin a mawng lamah a zawk zel a, Sihmit lui a fin ang. Sihmit lui chu a mawng lama zawk thla zelin Bulbekzawl nen a intina starting point a fin ta a ni.

II. BULFEKZAWL V/C BOUNDARY :

Sihmit Lui chu starting point a ni ang a. Pu San (Pu Tlanghlira cnui kawr ni bawk) khawchhak lamah zawk chhovin kawn thlen hmaah hmarchhak lam hawin tlangdungah chhovin Bulbekzawl Lawidai koah kal zelin Hruaikawn Meidet tlang chhipao kal liamin Faikha a fin ang.

Faikha chu chhimchhak zawnga zawk zelin Tuidir kawr hnar a fin ang.
Tuidir kawr chu khawehhak zawnga zawk thlain Tiau lui a fin ang.

Tiau lui chhim zewnga zawk thla zelin Sihmit luiin Tiau a finnaah Sihmit
Lui chu khawthiang zwng a zawk chhovin Pu Sangkima Tuilak kawr starting
point a fin lek chiah ang.
