NOTIFICATION

No.MADC.1/LAD/2000-2001/286, the 30th March, 2001. In pursuance of Executive Committee Meeting 10th resolution No. 3 and sub-section 1 of section 28 of the Mara Autonomous District Council (Village Council) Act, 1974, the Executive Committee of the Mara Autonomous District Council is pleased to demarcate the boundary of the Village Council New Siaha 'E' and New Siaha 'W'.

This order will take effect from issue of this order.

Detail Boundary description of New Siaha 'E' and New Siaha 'W' Village Council boundary demarcation is as below:—

1. NEW SAIHA II VILLAGE COUNCIL AREA BOUNDARY

A boundary line starts from the Middle of a cliff on E.G.S. Road at Seidia Stream. Moving up East-wards alongwith the course of the Stream towards its source, it reaches a confluencing point of Seidia Stream with a small ditch running up and proceeds alongwith the said ditch till it reaches P.W.D. Road near Sobji Bazar in between Mr. Zamanga's House site and Mr. F. Lianhluna's House site. (Mr. Zamanga's House site falls under the Jurisdiction of New Saiha-II Village Council Court and Mr. F. Lianhluna under New Saiha-I).

It crosses P.W.D. Read and goes East-wards alongwith the ditch till it reaches the Point of its source in between Deputy Commissioner Residential Bungalow and its Departmental Quarter (D. C. Bungalow falls under New Saiha-II Village Councils Jurisdiction and its Quarter under New Saiha-I Village Councils Jurisdiction).

It, then, moves down straight and reaches the source of a slaughter House water point on P.W.D. Road.

It, thence, runs North wards alongwith P.W.D. Road till it reaches the boundary line of I. B (PWD) side and Mr. Thankhara's House site and runs alongwith the said boundary upto P.W.D. Road. It crosses P.W.D Road in bet ween Mr. Thankhara House site and Mr. Vante's House site and meets the lower P.W.D. Road running towards A.O.C. It crosses P.W.D. Road and runs west-wards alongwith a small ditch near Mr. Ni-kama's House site. (Mr. Ni-kama's House site falls under Siahatla Village Councils Jurisdiction) till it reaches Islai Stream. From this a boundary line runs South-West alongwith Islai Chava and reaches its confluencing Point with Ratai Stream. It, then moves East-wards alongwith Ratai Stream towards its source till it reaches K.T.P. Water Point below E.G.S. Road.

It, then, runs South-wards alongwith E.G.S. Road up to a stiff below P.H.E. Water Pump House and goes up East-Westerly to go alongwith the boundary line of Higher Secondery School Complex and U.P.C. Local Church site. (U.P.C. Local Church is under College Vaih Village Council Court's Jurisdiction) and meets the starting boundary line.

2. NEW SAIHA-I VILLAGE COUNCIL AREA BOUNDARY.

Starting from the Middle of a cliff on E.G.S. Road at Seidia Stream, it runs South-wards alongwith E.G.S. Road till it reaches Seidia Vatiepa Stream at the side of Mr. Thanawna House site and runs alongwith the boundary line of site owned by Mr. Thangkhuma and Mr. Zakulla and proceeds along the same boundary turning towards South East till it reaches the boundary line of Soil Department and Mr. M. Sangchhina's House site. Running along their boundary line, it cuts a cross a stone step in between Mr. L. Patha and Mr. Lalhupa's House site. Going Straight alongwith the boundary line of L. Patha and Soil Department it reaches P.W.D. Road.

It thence, runs East wards alongwith the P.W.D. Road and reaches Pawpy Water Point approach Road near Mr. K. H. Beihlo's House site. (Mr. K. H. Beihlo House site falls under N. Colony Village Councils Jurisdiction) It runs East wards alongwith Pawpy Water Point approach Road till it reaches the said Water Point, below F. Rotluanga House site. The boundary line moves Southwards alongwith a Stone Step up to P.W.D. Road in between Dr. Lenghaia's House and Mr. N. Chama's House. It cuts across P.W.D. Road and moves up South-wards alongwith P.W.D. Road below Hospital and meets a Hospital Road. It, then, crosses the Road on the boundary line of Medical Department and Police Department following region Water Point approach Road and reaches the region Water Point.

From this Point, it goes up on the boundary line of Mr. B. Tevo's House site and Medical Department and reaches a small ditch in between Mr. B. Tevo's site and 18th AR site. It follows up the ditch towards its source and joins P.W.D. Road at its curve portion. It, thence, runs along with P.W.D. Road towards

Siahatlah up to the ditch located just beyond 18th A.R Camp. It then, goes down alongwith the ditch till it reaches Bualte lui (Stream). From this it moves North-West alongwith the course of Bualte Stream towards its source till it reaches its confluencing Point with the course of a Slaughter House Water Point. And it follows the course of the same Water Point towards its source and meets New Saiha-II Village Councils boundary line on P.W.D. Road running towards Siahatlah.
