NOTIFICATION

No. F. 23015/1/99-AH&V, the 23rd July, 2001. In exercise of the powers conferred under section 18 of the Mizoram Regulation of Animal Movement Act, 2000 (Act No. 6 of 2000) the Governor of Mizoram is pleased to make the following rules namely:—

THE MIZORAM REGULATION OF ANIMAL MOVEMENT RULES, 2001.

CHAPTER - I

PRELIMINARY

- 1. Short title, extent and commencement.
 - (i) These Rules shall be called the Mizoram Regulation of Animal Movement Rules, 2001.
 - (2) They shall extend to such areas where the Act is in force.
 - (3) They shall come into force on such date as the Government may, by notification in the Mizoram Gazette, appoint and different dates may be appointed for different provision of these rules or for different areas.

2. Definitions.

In these Rules, unless the context otherwise requires, —

- (1) "Act" means the Mizoram Regulation of Animal Movement Act, 2000 (Act No. 6 of 2003);
- (2) "Animals" means as definded in clause (a) of section 2 of the Act;

- (3) "Director" means Director of Animal Husbandry and Veterinary Department, Government of Mizoram:
- (4) "Department" means Department of Animal Husbandry and Veterinary Department;
- (5) "Examiner" means Registered Veterinary Officer posted at the animal Check Gates;
- (6) "Form" means a form under these rules;
- (7) "Government" means Government of Mizoram;
- (8) "Section" means a section of the Act;
- (9) "Veterinary Officer" means any Registered Veterinary practitioner serving under Government of Mizoram.

CHAPTER - II EXAMINATION OF ANIMAL AT THE CHECK GATE

- 3. (1) Restriction on liberal animal trafficking into Mizoram State from outside States, and examination of the animals at the Animal Check Gates set up by the Animal Husbandry and Veterinary Department, Mizoram along the State boundary, as per sub-section (5) of section 3 of the Act shall be registered in Form-A. Such diseased animal may be sent back depending on the gravity of the disease by which the animals is infected.
 - (2) Subject to the provision of the Recruitment Rules for the time being in force, such examiner to be appointed under section 4 may be appointed either by direct recruitment or by transferring such officers not below the rank of Veterinary Assistant Surgeon.

Provided that any registered Veterinary Officer in the Department may function as examiner for the purpose of examination of such animal coming from outside the State which are suspected to have escaped years examination at any Check Gates, at any place within Mizoram.

- (3) A fee for examination of each animal shall be collected from the owner of such animal as prescribed in Form-B and receipt of the examination fee shall be issued by the Examiner of such animal as in Form-C.
- (4) The examination fee collected shall be deposited into the nearest Go-ODD: evernment Treasury at least once in a month by the concerned Officer through the concerned Drawing and Disbursing Officer and shall be credited into the head of Account-0403-A.H.800-Other Reciepts.

- (5) Rates of examination fee shall be revised after every two years from the date of the last revision of such a fee by the Director or as and when considered necessary by the Government.
- (6) Animal examined for which soundness certificate is issued shall be given branding mark as deemed fit and proper by the Department from time to time and such animals so branded shall be entered in a register of examination by the concerned Examiner.
- (7) The account relating to collection of examination fee shall be audited by the Finance and Account Officer of the Department at least once in a quarter.

CHAPTER -III

DETENTION OR SEGREGATION, EUTHANISATION AND DESTRUCTION OF CARCASS OF DISEASED ANNIMAL

- 4. (1) Segregated or detained animal shall be released if and when recovered from the infection of scheduled disease, and shall be allowed to enter into the State of Mizoram with the certificate of soudness issued by the examiner. The expenditure, on feeding or medication of animal during segregation or defention, if any, shall be borne by the owner of animal.
 - (2) Carcass of animal due to infection of scheduled disease during segregation shall be buried or exhumed, in such a manner that the dorsal portion of the carcass is below six feet under the ground with or without germicidal chemical at the appointed places by the Department at least 200 metres away from the water-pond, stream, river or human dwelling place or as directed by the examiner according to the gravity of disease by which the animal was injected and as per guideline given by Veterinary jurisprudence and Veterinary medicinal practice for destruction of such careass.
