1. Now, therefore, the Government hereby notifies, under sub-section (i) of section 4 of the Land Acquisition Act, 1894 (Central Act 1 of 1.94) (herein fter referred to as the said Act) that the said land is likely to be needed for the purpose specified above.

2. Any person interested in any land being notified may submit their objection to the acquisition in Writing 10 the Deputy Commissioner, Aizawi, Collector, Aizawi within a period of 30 days from the date of publication of this Notification in the Mizoram Gazette, who will dipose of the objections and claims as per provision of Section 5-A of the land Acquisition Act, 1894.

3. All persons interested in the said land are hereby warned not to obstruct or interfere with any surveyor or other persons employed upon the said land for the purpose of the said acquisition. Any contract for the disposal of the said land by sale, lease, mortgage, assignment, exchange of the status of Pass or otherwise or any outlay commenced or improvement made therein without the sanction of the Collector will with der church of Sevenity has benefice 24 of the said Act, be disregard d while entersing woin purchicative under parts of the said land as may be finally acquired.
