## NOTIFICATION

No. B. 11035/8/98-EDN, the 1st August, 2001. Whereas the Govt. of India, Ministry of Welfare has conveyed the sanction of Rs. 1 crore vide their letter No. 14020/1/97-TDD dt. 4.3.1998 for setting up of one Tribal Residential School under Article 275 (1) of the Constitution of India in Mizoram as per the guidelines issued by them.

And whereas a society in the name of Tribal Welfare Education and Residential Institution has been formed and registered under the Societies Registration (extension to Mizoram), Act, 1976 vide registration No. SR/MZ-30 dt. 16th April, 1999;

And whereas the society has taken up the construction and setting up of Residential School in Mizoram as per the guidelines issued by the Govt. of India on the model of Andhra Pradesh;

Now, therefore, the Governor of Mizoram is pleased to constitute a State Level Board of Directors for setting up and management of Tribal Residential Schools to be established in Mizoram under Article 275 (1) of the Constitution of India comprising of the following with immediate effect :--

POWERS AND FUNCTIONS OF THE BOARD OF DIRECTORS;

The Board of Directors shall have control over the financial, administrative and the academic matters of the Schools in the following manners:-

- 1. To determine the qualification of the candidates to be recruited to the staff of the schools and us affiliating institutions.
- 2. To regulate the conditions of service of the staff of the School and its affiliating institutions in respect of scale of pay, leave allowances, sanctions of advances, travelling and daily allowances.
- 3. To administer the funds of the school and manage the properties of the Schools.
- 4. To determine the procedures to enter into agreement with other agencies, home and abroad for and on behalf of the schools.
- 5. To execute and approve detailed plans and programmes prepared and suggested for the furtherance of the objectives of the schools.
- 6. To determine the procedures, conditions and terms to affiliate the schools, any institutions having objectives similar to those of the schools or to recognise any other institutions.
- 7. To effectively implement the curricula, syllabi etc. as laid down by the Education Department either by the State Government or the Central Government.
- 8. To discharge such other functions from time to time as may be necessary for the proper management of the school.
