NOTIFICATION

(Under Sec. 21(a)(b) of Wildlife (Protection) Act 1972 (Central Act of 1972).

- No. D. 11011/34/2001-2002/DCL, the 8th August, 2001. Whereas the Government of Mizoram issued a Notification under Memo. B. 12012/17/2001-FST dt. 20. 7. 2001, deciaring its intention to declare the area specified at para 5 of this Proclamation, as "Thorang Tlang Elephant Project" within Lunglei District.
- 2. Consequent upon the said Notification by the Government of Mizoram to constitute the said Eephant Project, it has become necessary to enquire of any persons in or over the Land comprised within the limits of the project under Sec-18 read with Sec-19,20 and 21.
- 3. Now, therefore, I, C. Hmingthanzuala, I. A. S. Deputy Commissioner/Collector, Lung'ei District hereby issued a proclamation under Sec. 21 of this Wildlife (Protection) Act, 1972, calling upon any person (s) the undersigned within two months from the date of issue of this proclamation i. e. on or before 8. 10. 2001. The written claim in the prescribed form specifying the nature and extent of such rights with details of the amount and particulars of the compensation, if any, claimed in respect thereof, shall be filed before the undersigned within the above mentioned time, failing which the undersigned is bound to proceed under Sec. 22, 23, 24, 25 of the said Act or otherwise deem fit.
 - 4. The boundary details of the said proposed project is given below:
 - 5. Name of Area: Thorang Tlang Elephant Project.

Location : In between Kawnpui 'W' Village and Thenhlum Village within Lungiei District under Bunghaun 'W' R. D. Block.

Area ; 50 Sq. kms.

BOUNDARIES OF THORANG TLANG ELEPHANT PROJECT:

NORTH: Starting from River Tuicharlui it follows R. Tuicharlui unstreams and crossing Vaawk saddle thence, following Mualseilui down stream east-ward upto R. Tut.

EAST: From Mualseilui outlet the boundary follows R. Tut upstream till it meets outlets to Zotuilui.

SOUTH: From the outlet of Zotuilui, it follows Zotuilui upstream till it meets deserted footpath and then it meets R. Kau. It follows R. Kau downstream upto R. Saithah stream outlet and then follows R. Saithah upstream upto upper portion of Bamboo Supply Reserve Area.

WEST: From Bamboo Supply Reserve Area it goes towards North along the virgin Forest upto the North boundary starting point-Tuicnar lui.
