NOTIFICATION

No.J. 11013/1/98-LJE/52, the 21st August, 2001. Whereas the Central Government has notified the 22nd day of August, 1997 as the date on which the provisions of the Chapter-III of the Legal Services Authorities Act, 1987 (Act No. 39 of 1987) as amended from time to time, shall come into force in the State of Mizoram under Notification No.F.6(1) (16)/95 NALSA, dt. 26.8.1997.

And whereas the Hon,ble Chief Justice (Acting), Gauhati High Court has approved the constitution of five District Legal Services Authorities, i.e. Saiha, Champhai, Serchhip, Kolasib and Mamit vide No.HC.VII. 15/96/3474/A dt.7.8.2001.

Now, in exercise of the powers conferred under sub-section (1) of section 9 of the Legal Services Authorities Act, 1987, as amended from time to time, and read with Rule 10 of the Mizoram State Legal Services Authorities Rules, 1996, as amended from time to time, the Governor of Mizoram is pleased to constitute District Legal Services Authorities for the Districts of Saiha, Champhai, Serchhip, Kolasib and Mamit, with immediate effect, as follows :-
