TERMS OF REFERENCE

1. The SCVE will function as the overall policy formulating and co-ordinating body of the Government for Vocational Education and Training in Mizoram.

2. The specific functions to perform by the SCVE shall be as follows :

2.1. To prepare norms for the selection of institutions and collaborating institutions and for appointment of teachers in such institutions.

2.2. To develop norms for Vocational courses in terms of equipment and raw materials.

2.3 To take measures for establishing co-relation between employment opportunities and vocational courses.

2.4. To co-ordinate with various departments of the Government of Mizoram and other age..cies for facilitating apprehentionship, practical training of vocational students.

2.5. To advise the Government for the formation of District Vocational Committees.

2.6. To facilitate financial assistance to those seeking self-employment.

2.7. To conduct periodical review of the State Vocational Education Program me.

3. The term of the Council will be three years from the date of its constitution.
