THE POWERS AND FUNCTIONS OF THE HIGH POWER COMMITTEE SHALL BE AS FOLLOWS :

POWERS :

- i) To re-allocate fund from one Scheme to another within the District and within the sectoral allocation, provided that in case the proposed new scheme is not identical in nature with the scheme to be dropped, prior approval of the Government will be necessary ;
- ii) to recommend to the Government re-allocation of fund from one sector to another within the overall provision for the District ;
- iii) to draw up Calendar of Works for various Departments in the District and over-see their implementation ;
- iv) to have authority to pass structure against/give commendation to officers in the District in respect of their performance, which

will have to be recorded in the Annual Confidential Report (ACR) of the officers by their respective superior officers as Reporting officers ;

- v) to make such recommendation to the District Planning and Development Board or to the Government as deemed necessary in the interest of better Planning, Implementation and Monitoring ; and
- vi) to obtain information from any officer in the District regarding progress of Plan Scheme.

FUNCTIONS: i) To give guidance to the District Planning and Development Board in formulation of Plan proposals, implementation of programmes and monitoring ;

ii) to have quarterly review and occasional review of District plan ; and

iii) any other function that the Government may allot from time to time.

The Committee shall meet at least once in every three months. The Chairman and the Vice Chairman will have the power to co-opt any Govt. officials or any non-official (s) as member (s) of the Committee for any particular occasion.
