## NOTIFICATION

No.56/2001(i)/Jud.III.- In pursuance of sub-paragraph (2) of paragraph 17 of the Election Symbols (Reservation and Allotment) Order, 1968, the Election Commission of India hereby makes the following amendments to its Notification No.56/2001/Jud.III, dated 3rd April, 2001, namely :-
