The Board shall exercise such functions as envisaged under section 17 & 18 of the Water (Prevention & Control of Pollution) Act, 1974 aswell as those of Air (Prevention & Control of Pollution) Act, 1981.

The Chairman and Member-Secretary will function as part time and Conservator of Forest (R&D) shall function as Secretary of the Board in addition to his own duties.

The terms of office of the Chairman, Member Secretary and the members shall be three years from the date of constitution of the said State Pollution Control Board.

The Chairman of the Board shall be paid an honorarium of Rs. 1,000/- per month and members including Chairman and Member Secretary shall be paid sitting allowance of Rs. 200/- (Rupees two hundred) per sitting per day. The expenditure will be borne by MPCB.
