## NOTIFICATION

No.D.24016/9/2001-TC, the 13th November, 2001. The Governor of Mizoram is pleased to constitute, with immediate effect and until further orders, a Special Task Force for Marketing of Ginger with Pu Aichhinga, Minister, Trade & Commerce, Mizoram as Chairman.

The Special Task Force shall have the following members:

The Special Task Force shall carry out the following tasks:

- work out the broad policy frame-work for ginger marketing.
- examine necessity or otherwise of fixing floor rate.
- examine the necessity of registration or other-wise of ginger traders/buyers.
- explore urgently national and international market/buyers of ginger and make suggestions for maketing arrangement between buyers and sellers.
- examine necessity of sending trade delegation to main marketing centres of India and of our neighbouring countries for marketing ginger.

- contact Trifed and Tribal Affairs Ministry in New Delhi or any other relevant organization for marketing of ginger.
- identify ginger collection centres and arrangement of godowns as considered required within Mizoram.
- examine and, if considered required, make scheme for transport assistance to the ginger growers.
- any other matter that may facilitate the marketing of ginger.

The Special Task Force may co-op government officials of various departments of Government of Mizoram whenever deemed necessary.

All necessary secretarial support to the Task Force shall be provided by MAMCO, the Special Task Force may enlist the service of any staff or officer of different departments of Government of mizoram in carrying out its special tasks.

The Special Task Force shall work on daily basis for promoting ginger marketing and transactions between buyer and grow is of ginger but shall not itself directly assume the role of buyer and seller of ginger as ginger shall not be bought or sold by the government. The Task Force may make required decisions that may facilitate ginger marketing arrangement between buyers and sellers. However, matters which required policy decisions should be submitted to the Special Task Force to the appropriate authority of the Government.

The Special Task Force should submit report to the Government from time, at least once in a mouth.
