It is enacted by Parliament in the Fifty-Second Year of the Republic of India as follows:

#### CHAPTER I Section and

1. This Act may be called the Registration and Other Related Laws (Amendment) Act, 2001.

Short title.

#### CHAPTER II

#### AMENDMENT OF THE REGISTRATION ACT, 1908

16 of 1908.

2. In the Registration Act, 1908 (hereafter in this Chapter referred to as the Registration Act), after section 16, the following section shall be inserted, namely:

Insertion of new section 16A.

"16A. (1) Notwithstanding anything contained in section 16, the books provided under sub-section (I) of that section may also be kept in computer floppies or diskettes or in any other electronic form in the manner and subject to the safeguards as may be prescribed by the Inspector-General with the sanction of the State Government.

Keeping of books in computer floppies, diskettes, etc.

(2) Notwithstanding anything contained in this Act or in any other law for the time being in force, a copy or extracts from the books kept under sub-section (I) given by the registering officer under his hand and seal shall be deemed to be a copy given under section 57 for the purposes of sub-section (5) of that section."

Amendment of section 17.

- 3. In section 17 of the Registration Act,—
- (a) after sub-section (I), the following sub-section shall be inserted, namely:
  - "(IA) The documents containing contracts to transfer for consideration, any immovable property for the purpose of section 53A of the Transfer of Property Act, 1882 shall be registered if they have been executed on or after the commencement of the Registration and Other Related Laws (Amendment) Act, 2001 and if such documents are not registered on or after such commencement, then, they shall have no effect for the purpose of the said section 53A.";

(b) in sub-section (2), in clause (v), for the opening words "any document", the words, brackets, figure and letter "any document other than the documents specified in sub-section (IA)" shall be substituted.

Compulsory affixing of photograph, etc.

"32A. Every person presenting any document at the proper registration office under section 32 shall affix his passport size photograph and fingershall amx ms passes prints to the document:

Provided that where such document relates to the transfer of ownership of immovable property, the passport size photograph and fingerprints of each buyer and seller of such property mentioned in the document shall also be affixed to the document.".

- (a) under column heading "Description of Instrument", in article No. 23, in Exemption, the portion beginning with the words, "Assignment of Copyright" and ending with the word and figure "section 5," shall be numbered as clause (a) thereof, and after clause (a) as so numbered, the following clause shall be inserted, namely
