II. FUNCTIONS OF THE COMMITTEE :

- (1) Overall supervision and Monitoring of works under MIP in the District;
- (2) Submission of proposals which are beyond the purview of the DPC before the State Level Project Committee for consideration;
- (3) Scrutiny and approval of Action Plans for each of the villages prepared by the Farmers Associations and the PIAS.
- (4) Review of the progress of the works, at least once in a month, and submission of reports to the State Project Committee (SPC)
- (5) Submission of proposals for posting of Project Officers and Asstt. Project Officer to the SPC for consideration and approval.
- (6) Any other functions which are considered important and essential for proper and effective implementation of the Projects at the District Level.
