Short title and commencement

(1) These Rules may be called the Mizoram Labour & Employment Department (Group 'A' posts) Recruitment Rules, 2002

(2) They shall come into force on the date of their publication in the Official Gazette.

(b) Who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post (s):

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt any such person from operation of these rules.

6. Every Government servant recruited under these Rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

Notwithstanding anything contained in these rules, the Governor of Mizoram in public interest shall have the right and power to transfer any Officer so recruited under these rules to any other post or position which is equivalent in rank or grade.

Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to recorded in writing in consultation with the Department of Personnel and Administrative Reforms and Mizoram Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.

Nothing in these rules shall affect any reservations or other concessions required to be provided for the Scheduled Castes/ Scheduled Tribes and other categories of persons in accordance with the order issued by the Central Government or Government of Mizoram from time to time in this regards.

 All Rules pertaining to these posts framed by the Government of Mizoram under Notification No. L&ED 122/74/16 date 17/2/1975 and published in the Mizoram Gazette Issue No.16 dt.25.4.1975 in respect of the post of District Employment Officer stands hereby repealed :

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these Rules.
