NOTIFICATION

No. A. 12018/1/93-P&AR (GSW), the 26th February, 2002. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the posts of Employment Officer/Sub-Divisional Employment Officer under Labour & Employment Department, Government of Mizoram namely :-

Short title and commencement.

*

1. (1) These Rules may be called the Mizoram Lobour & Employment Department (Group 'B' posts) Recruitment Rules, 2002.

(2) They shall come into force on the date of their publication in the Official Gazette.

- Application 2. The Rules shall apply to the posts specified in culumn 1 of the First Schedule hereto annexed.
- Number of posts, 3. Classification and Scale of pay.

Method of recruit- 4. ment, age limit and other qualifications.

- The number of the said post(s), their classification and the scale of pay attached thereto shall be as specified in Columns 2-4 of the First Schedule as aforesaid.
- . The age limit, qualification and other matters relating to the said post shall be as specified in columns 5-14 of the First Schedule aforesaid :

Provided that the age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/Scheduled Tribes and other special categories of person in accordance with the orders issued by the Central Government or Government of Mizoram from time to time. 2

Disgualification

5. No peston—

(a) Who has entered into or contracted a marriage with a person having a spouse living, or

(b) Who, having a spouse living, has a cered into or contracted a marriage with any person shall be eligible for appointment to the said post s);

Provided that the Governor may if satisfied that such marriage is permissible under he personal law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt any such person from the operation of these rules.

Training and De- 6. Every Government servant recruited under these rules shall undergo such training or pass such departmental examination as may be prescribed from time to time.

Notwithstanding anything contained in these Rules, the Governor of Mizoram in public interest shall have the right and power to transfer any Officer so recruited under these rules to any other post or position which is equivalent in rank or grade.

Where the Governor is of the opinion that it is necessary 8. or expedient so to do, he may, by order and for reasons to be recorded in writing in consultation with the Department of Personnel and Administrative Reforms and Mizoram Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.

Nothing in these rules shall affect any reservations or 9. concessions required to be provided for the Scheduled Castes/Scheduled Tribes and other categories of persons the cicer issue by the Central in accordance with Government or Government of Wizoram from time to time in this regards.

All Rules pertaining to these posts from ed by the Govern-10. ment of Mizoram under Notification No. L & ED 122/74 /16 date 17.2.1975 and published in the Mizoram Gazette Issue No 7 date 21.2.1975 in respect of the post of Employment Officer stand hereby repeated.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general order ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
