The Mizoram Appropriation (N0.1) Act, 2002

(Act No.6 of 2002)

(Received the assent of the Government of Mizoram on the 28th March, 2002)

AN

ACT

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State for the services of the Financial Year of 2001-2002

It is hereby enacted by the Legislative Assembly of Mizoram in the Fifty Third Year of the Republic of India as follows :-

Short Title

1. This Act may be called the Mizoram Appropriation (No. 1) Act, 2002

Issue of Rs. 329,73,99,000 out of 2. the Consolidated Fund of the State of Mizoram for the Financial Year 2001-2002 From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied in Column (5) of the Schedule, amounting in the aggregate to a sum of Rupees Three hundred twenty nine crores seventy three lakhs and ninety nine thousand only for defraying the several charges which will come in course of payment during the Financial Year 2001-2002 in respect of the services specified in column (2) of the Schedule.

Appropriation

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.
