The Mizoram Appropriation (Vote on account)(No. 2) Act, 2002

(Act No. 7 of 2002)

(Received the assent of the Governor of Mizoram on the 28th March, 2002)

AN

ACT

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State for the Services in respect of the month of April-June, 2002.

It is hereby enacted by the Legislative Assembly of Mizoram in the Fifty Third Year of the Republic of India as follows:-

Short title

-1

- 1. This Act may be called The Mizoram Appropriation (Vote on account) (No. 2) Act, 2002
- Issue of Rs. 323,57,87,000/- out of 2. the Consolidated Fund of the State of Mizoram for the month of April-June, 2002.
- From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied sums not exceeding those specified in column (5) of the Schedule, amounting in the aggregate to a sum of Rupees Three hundred twenty three crores, fifty seven lakhs and eighty seven thousand only towards "Vote on Account" for defraying the several charges which will come in course of payment during the month of April-June, 2002 in respect of the services specified in column (2) of the Schedule.

Appropriation

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.
