#### NOTIFICATION

No.A. 12011/6/94-DCA, the 27th March, 2002. In exercise of the powers conferred by clause (h) of Sub-Paragraph (6) of Paragraph 2 of the Sixth Schedule to the Constitution of India, the Governor of Mizoram is consultation with the Lai Autonomous District Council is pleased to make the following rules relating to the recruitment to the post of Private Secretary to Chief Executive Member under Lai District Council, namely:-

- 1. Short title and commencement
- 2. Application
- 3. Number of Posts, Classification and scale of pay.
- 4. Mode of recruitment, age limitand other qualifications

- 1. These Rules may be called the Lai District Council (Group B Post Gazetted) Recruitment Rules, 2002
- 2. They shall come into force on the date of their publication in the Official Gazette.
- 3. The number of the said post its classification and the and scale of pay attached thereto shall be as specified in columns 2 to 4 in the Annexure-I aforesaid.
- 4. The mode of recruitment, age-limit, qualification and other matters relating to the said post shall be as specified in column 5 to 14 of the said Annexure-I

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other Backward classes or special categories of persons in accordance with the orders issued by the Central Government and by the Government of Mizoram from time to time.

5. Disqualification

٢

No person -

(a) Who has entered into or contracted a marriage with a person having a spouse living, or

(b) Who having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any such person from the operation of this rule.

6. Training and Departmental examination

Every person appointed to the post under these Rules shall undergo such training or pass such Departmental Examination as may be prescribed by the Council from time to time.

7. Power to relax

Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing and in consultation with the concerned Executive Committee, relax any of the provisions of these Rules with respect to any class or category of persons.

8. Reservation and other concessions

Nothing in these Rules shall affect any reservations and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes and other categories or classes of persons in accordance with the orders issued by the Central Government and or Government of Mizoram from time to time.

9. Repeal and Saving

All Rules pertaining to this posts if framed by the Governor of Assam or by the Government of Assam or by the Mizo District Council or Pawi-Lakher Regional Council or by the Pawi Autonomous District Council and were in force and continued to be in existence shall stand hereby repealed.

Provided that any order made or anything done or any action taken under the Rules so repealed or under any general order (s) ancillary thereto shall be deemed to have been made, done or taken under the corresponding provisions of these Rules.
