2. FUNCTIONS OF THE AUTHORITY :

- 1) The Mizoram Intodelhna Project (MIP) Executive Authority will be in the nature of an empowered group responsible for effective monitoring and evaluation of the implementation of the MIP and will function under the supervision and guidance of the High Level Committee of MIP.
 - 2) The MIP Executive Authority, individually or in groups, will undertake field visits as frequently as possible, and in any case, at least once in a month, to monitor and evaluate the progress of implementation of the Mizoram Intodelhna Project.
 - 3) The MIP Executive Authority will take necessary follow up actions on the findings of the field visits as well as on the reports received from the Vigilance Cell, District Level Monitoring Committee and Village Level Monitoring Cell.
 - 4) The MIP Executive Committee will also undertake any other assignment relating to MIP as given to it by the MIP High Level Committee, from time to time.
 - 5) The MIP Executive Authority will meet as frequently as possible, and in any case, at least once in a month, regularly.
 - 6) The decision of the MIP Executive Authority will be implemented by the MIP Office which will be set up by the Agriculture Department, Govt. of Mizoram.
3. Consequently, the Governor of Mizoram is further pleased to dissolve the State Level Monitoring & Evaluation Committee on Mizoram Intodelhna Project (MIP) notified under Memo No. B. 13018/5/2002-RD dt. 17/1/2002, with immediate effect.
