NOTIFICATION

No. B. 12012/17/2001-FST, the 23th April, 2002. Whereas, in exercise of the powers conferred by Section 18 read with Section 19, 20 and 21 of the Wildlife (Protection) Act, 1972, the Governor of Mizoram by reason of the adequate ecological, faunal, floral, geomorphological, natural or zoological significance has declared his intention vide Notification of even No. dt. 20.7.2001 read with Notification dt. 4.9.2001 to constitute the area specified in the Schedule to this Notification as "Wildlife Sanctuary" for the purpose of protecting, propagating or developing wildlife therein and its environment.

Whereas, in exercise of the powers conferred by Section 14,15,16,17,19 read with Section 21 of Mizo District Forest Act, 1955, the Government has already declared the area of Thorang tlang as Reserve Forest known as Thorang tlang Reserve Forest.

Now, therefore, in exercise of the powers conferred by Section 26-A (I) (b) of the Wildlife (Protection) Act, 1972, the Governor of Mizoram hereby declares the said area as specified in the Schedule below as Thorang Tlang Wildlife Sanctuary with immediate effect and until further orders.

SCHEDULE

Name of the area : Thorangtlang Wildlife Sanctuary.

Location : In between Kawnpui 'W' village and Thenhlum Village
within Lunglei District under Bunglei W. R.D. Block.

Area : 50 Sq. Kms.

BOUNDARIES OF THORANG TLANG WILDLIFE SANCTUARY

- NORTH** : Starting from river Tuicharlui it follows R. Tuicharlui upstreams and crossing Vaawk saddle thence, following Mualseilui downstream east-ward upto R. Tut.
- EAST** : From Mualseilui outlet the boundary follows R. Tut upstream till it meets outlet of Zotuilui.
- SOUTH** : From the outlet of Zotuilui, it follows Zotuilui upstream till it meets deserted footpath of Dampui Village at the junction of Kawnpui village footpath and then it meets R. Kau. It follows R. Kau downstream upto R. Saithah stream outlet and then follows R. Saithah upstream upto upper portion of Bamboo supply reserve area.
- WEST** : From Bamboo supply reserve area it goes towards North along the virgin Forest upto the North boundary starting point-Tuicharlui.
