NOTIFICATION

No. D. 11031/22/99-LAD/78, the 11th June, 2002. Whereas the State Government in exercise of the powers vested in it vide Sub-Section (1) of Section 18 of the Mizoram Urban & Regional Development (Amendment) Act, 1996 (No. 12 of 1990 & 1996) has approved the Greater Aizawl Development Plan/Master Plan 2011 extending an area of 128.98 Sq. Km. (approx.) covering 8 Assembly Constituencies and 71 Village Councils as in Annexure I as per text and maps etc. hereunder, after wide publication inviting objections/suggestions and public consultation under Sub-Section (1) of Section 17 of the said Acts, within thirty (30) days from the date of notification and in consultation within the Mizoram Urban Planning & Development Board as required under Sub-Section (1) of Section 18 of the said Act and no objection has been received with regard to the aforesaid draft Development Plan notification.

2. Now, therefore, in exercise of the power vested in him vide Sub-Section (4) of Section 18 of the said Act, the Governor of Mizoram is pleased to publish Greater Aizawl Development Plan/Master Plan 2011 as approved by the State Government and give the notice that a copy of the said Development Plan may be inspected at the following offices free of cost during office hours, namely :--

- 1. Deputy Commissioner, Aizawl District, Aizawl.
- 2. Director, Local Administration Department, Aizawl.
- 3. Chief Planner/Senior Town & Country Planner, Aizawl.
- 4. Central Y.M.A., Aizawl.

The said Development Plan shall come into operation and shall be binding on all Government & Semi-Government Departments and Local Authorities/Village Councils functioning within the Greater Aizawl City Planning Areas vide Sub-section (5) of Section 18 and Sections 22, 23, 24 & 25 of the said Act with effect from the date of the publication of this.
