NOTIFICATION

No. K. 15011/86/99-REV, the 25th June, 2002. Whereas it appears to the appropriate Government (hereinafter referred to as the Government of Mizoram) that the land specified in the scheduled thereto (hereinafter referred to as the "said land") is likely to be needed for public purpose viz. Acquisition of land at Luangmual for Inter State Police Wireless Station.

1. Now, therefore, the Government hereby notifies, under sub-section (i) of section 4 of the Land Acquisition Act, 1894 (Central Act 1 of 1894) (hereinafter referred to as the said Act, that the said land is likely to be needed for the purpose specified above.
2. Any person interested in any land being notified may submit his/her objection to the acquisition in writing to the Assistant Settlement Officer-1, Aizawl/Collector, Aizawl within a Period of 30 days from the date of publication of this Notification in the Mizoram Gazette, who will dispose of the objections and claims as per provision of Section 5-A of the land Acquisition Act-1894.
3. All persons interested in the said land are hereby warned not to obstruct or interfere with any surveyor or other persons employed upon the said land for the purpose of the said acquisition. Any contract for the disposal of the said land by sale, lease, mortgage, assignment exchange of the status of Pass or otherwise or any outlay commence or improvement made therein without the sanction of the Collector will, under clause (7) of Section 24 of the said Act, be disregarded while assessing compensation for such parts of the said land as may be finally acquired.
