H.12018/83/98-LJD/116, the 27th June, 2002. The following Act of the Mizoram Legislative Assembly which received the assent of the Governor of Mizoram is hereby published for general information.

The Mizoram Appropriation (No. 3) Act, 2002.
Act No. 10 of 2002

Received the assent of the Governor of Mizoram on the 13th June, 2002.

AN ACT

to authorise payment and appropriation of certain sums from and out of the consolidated Fund of the State for the Services of the Financial Year of 2002—2003.

It is enacted by the Legislative Assembly of Mizoram in the Fifty Third Year of the Republic of India as follows :—

Short Title

Issues of Rs. 1294,52,21,000/- out of the Consolidated Fund of the State of Mizoram for the Financial Year 2002—2003.

1. This Act may be called the Mizoram Appropriation (No. 3) Act, 2002.
2. From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied in column (5) of the Year Schedule, amounting in the aggregate to the sum of Rupees One thousand two hundred ninety four crores, fifty two lakhs and twenty one thousand only for defraying the

several charges which will come in course of payment during the Financial Year 2002—2003 in respect of Service specified in column (2) of the Schedule.

Appropriation

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.
