# NOTIFICATION

No. A. 12018/1/97-P&AR (GSW), the 30th July, 2002. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the posts of Inspector (Mechanic) and Sub-Inspector (Mechanic) under Police Department, Government of Mizoram namely :-

Short title and 1. (1) These Rules may be called the Mizoram Police De-partment (Group 'B' post) Recruitment Rules, 2002. commencement. de later deservations (2) They shall come into force from the date of their publication in the Official Gazette.  $X_{i}(q_{i})$ Application 2. The Rules shall apply to the posts specified in column 1 of the First Schedule hereto annexed. 

Classification and Scale of pay.

Number of posts, 3. The number of the said post(s), classification and the scale of pay attached thereto shall be as specified in Columns 2-4 of the First Schedule aforesaid.

Method of recruit- 4. The age limit, qualification and other matters relating to ment, age limit the said post shall be as specified in columns 5-14 of the First Schedule. and other qualifications.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candi-dates belonging to the Scheduled Castes/Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time.

Disqualification 5. No person -

- (a) Who has entered into or contracted a marriage with a person having a spouse living, or
- (b) Who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment ιo the said post.

Provided that the Governor of Mizoram may, if satisfied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of this Rules.

Training and<br/>Departmental<br/>Examination6.Every Government servant recruited under these<br/>Rules shall undergo such training or pass such De-<br/>partmental Examination as may be prescribed from<br/>time to time.

- Power to transfer 7. Notwithstanding anything contained in these Rules, the Governor of Mizoram in public interest shall have the right and power to transfer any Officer or Official, recruited in accordance with these Rules to any post/posts/service specified in schedue to these rules to any other post or posit on which is equivalent in rank or grade.
  - Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing in consultation with the Selection Committee/Departmental Promotion Committee through the Department of Personnel and Administrative Reforms, relax any of the provisions of these Rules with respect to any class or category of persons.

Nothing in these Rules shall affect reservation or other concessions required to be provided for the Scheduled Castes/Scheduled Tribes and other categories of persons in accordance with the order issued by the Central Government or Government of Mizoram from time to time in this regard.
