No D.26017/1/94-TRP, the 28th August, 2002. In exercise of the powers conferred by clause (i) of sub-section (1) of Section 67 of the Motor Vehicle Act, 1988 (59 of 1988) and in supersession of this Deptt's Notification issued earlier in this regard, the Governor of Mizoram is pleased to direct the State Transport Authority of Mizoram to re-fix hiring charges of all categories of M.S.T. vehicles at the rates given below on payment in advance with immediate effect.
