NOTIFICATION

No.A. 12018/52/80-APT'B), the 11th September, 2002. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of Despatch Rider under the Government of Mizoram, namely :--

Short title and commencement

Application

Number of posts, 3. Classification and scale of pay

Method of recruit- 4. ment age limit and other qualifications

- 1. (1) These Rule may be called the Mizoram Despatch Rider (Group' C' post) Recruitment Rules 2002.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. The Rules shall apply to the post specified in column I of the First Schedule hereto annexed.

The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the First Schedule aforesaid.

The age limit, qualification and other matters relating to the said post shall be as specified in columns 5 to 14 of the First Schedule aforesaid:

Provided that the age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Govt. or Government of Mizoram from time to time. Disgualification

5. No person-

(a) Who has entered into or contracted a marriage with a person having a spouse living, or

(b) Who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post(s):

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt any such person from the operation of these regulations.

Every Government servant recruited under these Rules Training and De-6. shall undergo such training or pass such Departmental examination as may be prescribed from time to time.

- contained in these Rule. Notwithstanding anything Power to transfer 7. the Governor of Mizoram in public interest shall have the right and power to transfer any Officer so recruited under these kules to any other post or position which is equivalent in rank or glade.
- Where the Governor is of the opinion that it is neces-8. Power to Relax sary or expedient so to do, he may, by order and for reasons to be recorded in writing in consultation with the Department of Personnel and Administrative Reforms relax any of the provisions of these Rules with respect to any class or category of persons.

9. Nothing in these Kules snall affect any reservations or other concessions required to be provided for the Scheduled Cast_S/Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Government of Mizoram from time to time in this regards.

10. All Rules pertaining to these posts framed by the Government of Mizoram under Nonfication No. A. 12018/52/80-APT (B, at. 29.8.2000 and No. A. 12018/52/80-ArT (B) dt. 6.12.2000 published in the Mizoram Gazette Issue No. 237 at. 6.9.4000 and Issue No. 309 at. 9.11.2000 stand hereby repeated:

Provided that any order made or anything done or taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
