THE SALARIES AND ALLOWANCES OF OFFICERS OF PARLIAMENT AND LEADERS OF OPPOSITION IN PARLIAMENT (AMENDMENT) ACT, 2002

AN ACT

further to amend the Salaries and Allowances of Officers of Parliament Act, 1953 and the Salary and Allowances of Leaders of Opposition in Parliament Act, 1977.

BE it enacted by Parliament in the Fifty-third Year of the Republic of India as follows :—

CHAPTER I PRELIMINARY

1. (1) This Act may be called the Salaries and Allowances of Officers of Parliament and Leaders of Opposition in Parliament (Amendment) Act, 2002. Short title and commencement

(2) It shall be deemed to have come into force on the 17th day of September, 2001.

CHAPTER II

AMENDMENT TO THE SALARIES AND ALLOWANCES OF OFFICERS
OF PARLIAMENT ACT, 1953

Amend- 2. In section 5 of the Salaries and Allowances of Offi-
ment of cers of Parliament Act, 1953, the following proviso
section 5 of shall be inserted, namely :—

“Provided that on and from the 17th day of Sep-
tember, 2001, the sumptuary allowances shall be paid to—

(a) the Speaker of the House of the People at
the same rate at which the sumptuary allowance is
payable, under section 5 of the Salaries and Allowan- 58 of 1952
ces of Ministers Act, 1952, to every other Minister who
is a member of the Cabinet;

(b) the Deputy Chairman and the Deputy Speaker
at the same rate at which the sumptuary allowance is
payable, under section 5 of the Salaries and Allowan- 58 of 1952
ces of Ministers Act, 1952, to a Minister of State.”

CHAPTER III

AMENDMENT TO THE SALARY AND ALLOWANCES OF LEADERS
OF OPPOSITION IN PARLIAMENT ACT, 1977

“Provided that on and from the 17th day of Sep-
tember, 2001, the sumtuary allowance shall be paid to
each Leader of the Opposition at the same rate at
which the sumptuary allowance is payable, under sec-
tion 5 of the Salaries and Allowances of Ministers Act,
1952, to every other Minister who is a member of the 58 of 1952.
