No.56/2002(v)/Jud.III.- In pursuance of sub-paragraph (2) of paragraph 17 of the Election Symbols (Reservation and Allotment) Order, 1968, the Election Commission of India hereby makes the following further amendments to its Notification No.56/2002/Jud-III, dated 10th January, 2002 as amended vide notifications dated 2nd May, 2002 and 12th July, 2002, namely :—
