Any payment already made by the consumer if any, should be adjusted according to the revised rate of tariff. Whatever excess payment made as worked out by the recalculation, should be treated as advance payment for the next succeeding energy bills. Surcharges/penal interests, if any, arising out of billing with retrospective effect from 1. 8. 2002 are waived.

The Governor of Mizoram is further pleased to order that-

1. "Unmeter Supply (Applicable for connection without meter) appears in all the categories of the tariff may be read as "Unmetered Supply".

2. Category-12 temporary Power Tariff section B "Unmetered Supply (C) may be read as "The Complete wiring for which temporary supply of power is required shall be arranged by the applicant at his own expense. It will also be the responsibility of the applicant to ensure that the wiring conforms to the technical requirements as specified by Power & Electricity Department" ginstead of "The complete wiring for which temporary supply of power is required shall be arranged by the applicant at his own expense.
