## NOTIFICATION

No.K-15011/86/99-REV, the 23rd January, 2003. Whereas by Government Notification K-15011/86/99-REV Dt. 25.6.2002 published in the Official Gazette and two daily newspapers, it was notified under section 4 of the Land Acquisition Act, 1894 (Central) Act 1 of 1894 (ne ematter referred to as the "said Act") that the land specified in the scnedule appended to the said Notification was likely to be needed for the purpose namely Acquisition of land at Luang nual for Inter State Police Wireless (ISPW).

And whereas the appropriate Government (hereinafter referred to as the "Government of Mizoram") after considering the report made under sub-section (2) of section (5) (A) of the said Act is satisfied that the land is needed for the purpose specified above.

Now, therefore, the Government declare under section 6 of the said Act that the said land is required for the public purpose specified above.

The Government also appoints Deputy Commissioner Aizawl, under clause (C) of section 3 of the said Act to perform the functions of a Collector for all proceedings hereinafter to be taken in respect of the said land and directs him under section 7 of the said Act to take order for the acquisition of the said land.

The Collector shall thereupon cause the land to be measured and make a plan of the same under section 8 of the said Act if not already done as per section 4 of the said Act, and dispose of all objections and claims after causing a public notice for not less than 15 days to the persons interested stating the Government is intention of taking over the possession of the said land as per section 9 of the said Act. Then, the collector shall submit a Draft Award to the Government of Mizoram after fulfilling the provisions under section 11 of the said Act.

A plan of the said can be inspected at the Office of the Deputy Commissioner, Aizawl till the final award is made under section 11 of the said Act.
