In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of Instructor (Anganwadi Worker Training Centre) under Social Welfare Department, Government of Mizoram, namely :--

Method of recruit- 4. ment, age limit and other qualifications

- The Rules shall apply to the posts specified in column 1 of the First Schedule hereto annexed.
- The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the First Schedule as aforesaid.

The age limit, qualification and other matters relating to the said post shall be as specified in columns 5 to 14 of the First Schedule aforesaid:

Provided that the age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Govt. or Government of Mizoram from time to time.
