In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of Instructor (Anganwadi Worker Training Centre) under Social Welfare Department, Government of Mizoram, namely :--

Method of recruit- 4. ment, age limit and other qualifications

- The Rules shall apply to the posts specified in column 1 of the First Schedule hereto annexed.
- The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the First Schedule as aforesaid.

The age limit, qualification and other matters relating to the said post shall be as specified in columns 5 to 14 of the First Schedule aforesaid:

Provided that the age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Govt. or Government of Mizoram from time to time.

Training and De- partmental Exa- mination.	6.	Every Government servant recruited under these Rules shall undergo such training or pass such Departmental examination as may be prescribed from time to time.
Power to transfer	7.	Notwithstanding anything contained in these Rules, the Governor of Mizoram in public interest shall have the right and power to transfer any Officers so recruited under these Rules to any other post or position which is equivalent in rank or grade.
Power to Relax	8.	Where the Governor is of the opinion that it is neces- sary or expedient so to do, he may, by order and for reasons to be recorded in writing in consultation with the Department of Personnel and Administrative Reforms relax any of the provisions of these Rules with respect to any class or category of persons.
Reservation and other Concessions	9.	Nothing in these Rules shall affect any reserva- tions or other concessions required to be provided for the Scheduled Castes/Scheduled Tribes and other categories of persons in accordance with the order issued by the Central Govt. or Government of Mizoram from time to time in this regards.
